- \* Exhibit space canceled after July 7, 2022 is not refundable.
- \* Exhibitors agree to have said booth setup by 12:00 PM, Monday, July 18, 2022 and will not dismantle the said booth until after 9:00 PM Saturday, July 23, 2022.
- \* Exhibitor agrees to have said booth occupied by a qualified employee of said company each day from 5:00 PM – 9:00 PM on Monday thru Saturday
- \* Exhibitor agrees to keep said booth clean and presentable at all times and agrees that all materials being displayed will be acceptable for viewing by children.
- \* Exhibitors must adhere to the rules and regulations set fourth by the Posey County Fair Association, Inc.
- \* Exhibitors must also comply with all applicable federal, state, and local laws.
- \* The Posey County Fair Association, Inc reserves the right to accept or reject any application for exhibit space; to reassign exhibit space as deemed appropriate to the best interest of the fair; and to govern the construction, arrangement and appearance of exhibitor displays.
- \* Exhibitors agree to maintain and provide proof of General Liability Insurance and Workman's Compensation covering your employees listing Posey County Fair Association, Inc, its Board of Directors and Affiliates as additional insured, so as to fully protect both exhibitor and the Posey County Fair Association, Inc from any and all claims under Workers' Compensation Act or employee liability laws, and from any and all other claims for damage to property or for the personal injury, including death, made by anyone, which may arise from operation carried on under this contract, either by exhibitor, any subcontractor or by anyone directly or indirectly engaged or employed by either of them.

The Posey County Fair Association, Inc agrees to provide said company with said booth space during fair week. Each company will be provided with 2 complementary fair passes per space. Additional passes may be purchased for \$30.00 each and will be mailed to you along with a copy of the signed contract following the receipt of payment.
